P&S CYtation and Woodin CYtation Awards

P&S CYtation Award

Iowa State University is a great institution because talented individuals come here to work and to make a real commitment to excellence. This process is designed to recognize staff members, particularly those people who might not otherwise receive recognition for outstanding work that has been done. Iowa State University recognizes that sometimes an individual does something above and beyond the call of duty, and/or does something extraordinarily well, or acts in such a way as to make a notable difference in the institution.

For this reason, the Professional & Scientific Council is calling for nominations of P&S candidates for the "P&S CYtation Award."

P&S CYtation Award Criteria: The individual must be a P&S Employee (on or off campus) and must meet the following criteria:

- Performing above and beyond the call of duty
- Doing something extraordinarily well
- Acting in such a way to make a real difference to Iowa State University

What happens if a candidate is selected to receive a CYtation award?

The President will present each recipient with a certificate of recognition at the P&S Council Awards ceremony. A one-year family pass to Reiman Gardens will be sent separately from Reiman Gardens. Note: the pass cannot be given in anyone else's name other than the award recipient and the offer is void if the recipient is already a member of Reiman Gardens. Nominators and awardees will be notified of the award. Additional announcements may appear in Inside Iowa State, the P&S Council newsletter, or other Iowa State publications. Twelve to sixteen awards will be given annually.

Please Note: This is an individual award, not intended as a group award.

Woodin CYtation Award

In addition to the CYtation award, the Woodin CYtation award is available for qualified individuals. The criteria is listed below and must be addressed in the nomination and the box on the nomination form needs to be checked to be considered.

Dan Woodin was an information systems leader at Iowa State University and a long time P&S employee of 36 years. Dan served as P&S Council president an unprecedented four terms. He was also an Ames school board member who was known for his upbeat attitude. Dan believed in action and doing what needed to be done and not just sitting on the sidelines. He made a difference and lived by the following statement: "live in today, taking advantage of daily opportunities that will come your way, and live each day with integrity."

Dan passed away September 2013 after over a year-long battle with cancer. The Professional & Scientific Council would like to recognize his legacy here at Iowa State University and therefore is calling for nominations of P&S candidates for the "Woodin CYtation Award."

Woodin CYtation Criteria: The individual must be a P&S Employee and must meet the following criteria:

- Demonstrates exemplary service to P&S Council or P&S Employees.
- Demonstrates willingness to go above and beyond.
- Displays a great attitude, a true compassion for others, and treats everyone with respect.
- Demonstrates leadership, innovation, and initiative.

What happens if a candidate is selected to receive a Woodin CYtation award?

The President will present the recipient with a certificate of recognition at the P&S Council Awards ceremony. The winner will also receive two football tickets in the Athletics Department Balcony Suite for the first home football game of the following year. Additional announcements may appear in Inside Iowa State, the P&S Council newsletter, or other Iowa State publications. One award will be given annually.

Who can make nominations for the P&S CYtation and Woodin CYtation Awards? Any employee of Iowa State University can submit an award nomination for any P&S employee.
