5. Administrative Reports

Senior Vice President & Provost (Jonathan Wickert)

Welcome back everyone- I hope you had a great break and it is hard to believe we are already starting another semester. It was a quiet break, but there were a few things that did happen. We did have some press coverage about research misconduct findings in the College of Veterinary Medicine. There is a system in place that manages complaints of research misconduct and works with the federal agency. Conducting high integrity and quality research is our responsibility and we led the investigation in this scenario. The reality is that our faculty members are conducting great, high quality research and this was a circumstance that didn't meet our standards. We also had a chemical spill out at the research park last week and I mention this because of our communication system that is in place. We relied on our ISU homepage and email rather than the ISU alert system since it wasn't on campus and it was during a break period. We are continually learning and working to improve our system. We are going to have an upcoming announcement in the VPR search as well as the Economic Development area. We will also have more than \$200M in projects going before the Board of Regents this month. Finally, if you haven't been catching the men's and women's basketball games, you should definitely try and do so as we are doing quite well.

Faculty Senate (Veronica Dark)

- Since Senate has not met since the last time you all met, I won't have much of a report. I really appreciated the way that the incident with the chemical spill was handled. On the meeting of the Senate on the 21st, the President of the Board of Regents will be speaking. The meeting will be at 3:30pm.

University Human Resources (Julie Nuter)

Since some of you are new and I am in my early days, I want to convey my promise to keep you all up to date about my 30/60/90 day plan and my commitment to learning about ISU. I have met with a number of groups (including meeting with the Deans) and it has been great to get out and go to the buildings and become familiar with campus. I have also been meeting with the various groups under the VPSA area. I have been hearing a lot of opportunities as well as a lot of things that have been going well. I have also been able to investigate the priorities of the UHR office and what we can do to balance all of the demands that have come to our office. We have moved forward with the Wellness Coordinator position and those interviews are beginning in the near future. Another area that we have started to focus is the benefits survey that was done last spring. I am really asking people to take a pause and evaluate where we are and calibrate to where we need to go, especially with projects like the People Admin project. There have also been a number of the things on the wish list including performance management and a desire to have a more consistent process, having more training for management and those who aspire to be in those roles, professional development for the staff, and the services that UHR is able to provide and the clarity around some of those services. At this time I have more of the listening and learning tour going on and I hope to have a thoughtful plan of action moving forward. This is not only a short term plan but also a plan for the longer term as well.
