4. P&S Council Executive Committee Reports

President (Amy Tehan)

- Tera and I have asked to be put on the agenda for upcoming leadership meetings. We will be meeting with the Council of Deans on January 13th, the Department Chairs Cabinet in February, and with Martino Harmon of Student Affairs, Judy Hankin of Business & Finance, and Adam Schwartz at the Ames Laboratory. The purpose of these meetings is to market the professional development conference and make leadership aware of the representation and communication structure we've worked so hard to set up this year. We will also be giving the deans and the leadership from SA, B&F, and the Ames Lab that their council representatives will be contacting them to set up individual meetings soon. Tera and I will be putting together a talking points memo for all of the council reps to use during these individual meetings, and we'll be accompanying each of you to the meetings.
- Paul Tanaka attended the December P&S Executive Committee meeting to talk about the assignment of IP rights at the university. There is a recent court case in which Stanford University almost lost all IP rights and royalties to one of its researcher's inventions because that researcher unknowingly signed a contract with a corporation. Soon there will be language going into letters of intent for all P&S staff, faculty, and graduate students regarding IP assignment. The next step will be to have current employees sign a form.
