3. Administrative Reports

Senior Vice President & Provost (Jonathan Wickert)

- Reaccreditation of the University happens every 10 years. The Higher Learning Commission
 (HLC) completed a site visit recently (Sunday-Tuesday, November 1-3). They looked at the
 budget model, diversity issues, assessment of academic programs, and increased enrollment. In
 about two weeks ISU will receive a written report from HLC.
- ISU Strategic Planning recently had a kickoff to start the process to develop the next five year plan. The six subcommittees include: Student experience, Research profile, Economic development and service to lowa, Campus environment, Infrastructure enablers, and Additional creative opportunities. The committees will be solidified with faculty, staff, student, and stakeholder members. Draft of strategic plan should be completed around spring break (March), then public comment period, and finally should wrap up summer 2016.
- Efficiency study (TIER) on academic programs Elearning and Enrollment Management report is available on BOR website:
 http://www.regents.iowa.gov/Meetings/DocketMemos/15Memos/October2015/pappaspowerpoint102115.pdf). Consultants really understood the differences between the three state universities.
- Question from Council member about training for teaching online courses. Dr. Wickert
 mentioned the Online Teaching Hub through the library (http://www.celt.iastate.edu/online-learning-hub/), President's Flip Classroom Initiative (http://www.celt.iastate.edu/online-learning-hub/projects/flipped-initiative/), 80 classes right now that are flipping, impacting over 12,000 students. Need to explore ISU Extension involvement with online learning across the state.

Associate Vice President, University Human Resources (Clayton Johnson for Julie Nuter) UHR Slides sent out with minutes.

Faculty Senate (Robert Wallace)

- The Faculty Senate continues to discuss revision of PRS (professional responsibility statement) in Faculty Handbook. Task force submitted recommendations in April, tabled until fall, campuswide survey proposed action, 4 motions to vote on related to this topic.
- Faculty Senate will be discussing the discontinuing of the Botany major and looking at adding a GIS minor.

4. P&S Council Executive Committee Reports

President (Tera Lawson)

Good afternoon everyone!

It has been another busy month for Council and I'm happy to report that we have made some significant progress on several of the priorities identified during our July Priority Planning Session!

During the past month we have continued to look into the possibility of changing the tuition reimbursement from a 3 credit maximum to a 4 credit maximum and on our priority to look into P&S Employees who are also teaching.

In the next month we will continue to move both of these priorities forward by creating documents that propose changes and outline guidelines/best practices.

- We will be working to create a draft guideline/best practices document to guide conversations around Professional and Scientific Employees who also teach. This draft document would include information about:
 - How to calculate the percentage of time P&S Employees dedicate to teaching duties (up to the maximum of 30% as is stated in the Faculty Handbook);
 - The differences between having teaching as part of a P&S Employees Position
 Description and teaching outside of the position into which the individual was hired;
 - o Granting P&S Employees who teach faculty rank, and what that means and or looks like for both the Employee and the Department/Unit
 - o How P&S Employees should not have a PRS, what the PD is, and if changes need to be made to the employee's time allocation they should be made to the PD.
 - o That conversations need to occur and time spent needs to be discussed:
 - When the individual is asked to take on the teaching position.
 - There is an increased load over time due to student enrollments.

Any Councilors who are interested in helping to draft the guidelines/best practices document for Professional and Scientific Employees who also teach, should contact me as soon as possible as I am pulling together a group to draft this document. Once drafted we will work with the Provost's Office to finalize the document.

• We will also be drafting a proposal suggesting the potential changes to the tuition reimbursement program.

Any Councilors who are interested in helping to draft the proposal suggesting changes to the tuition reimbursement program, should contact me as soon as possible as I will be pulling together a group to draft this document.

My last item today is our second Special Report to Council! 15SP02 Acquiring Additional Information about the Emerging Leaders Academy Leadership Program and the P35 minimum paygrade eligibility requirement for P&S Employees.

Secretary (Kate Goudy-Haht)

Expenses for October totaled \$836.54, this included Memorial Union rental fees, IT services, Council flyer for University Orientations, constant contact newsletter and livestreaming fees for the seminar series.

VP for University Community Relations (Jessica Bell)

I attended the New Employee Orientation October 13th. In addition to the new handouts, I reminded them of the Seminar Series event the same day and highlighted the Employee Tuition Reimbursement Program.

VP for University Planning and Budget (Jordan Bates)

Jordan's slides sent out with minutes.

As discussed during the October meeting, I am in the process of scheduling meetings with University administrators across the representation areas to gain an understanding of the budgeting processes in each area. I met with Dr. Martino Harmon, Associate Vice President for Student Affairs and Bonnie Whalen regarding the budget process for the Division of Student Affairs Central Office and reporting units.

When talking about budget development for the Division of Student Affairs, there are fourteen reporting units involved in the process of submitting information and budget requests:

- Admissions
- Assessment and Enrollment Research
- Dean of Students Office
- Department of Residence
- International Students and Scholars Office
- ISU Dining
- Learning Communities
- Memorial Union
- Office of the Registrar
- Office of Student Financial Aid
- Student Counseling Center
- Student Support Services Program
- Thielen Student Health Center
- Upward Bound and Educational Talent Search

The Division of Student Affairs has a 20 person RMM Student Affairs Advisory Committee that reviews budget requests.

The Senior Vice President for Student Affairs (SVPSA) reporting units submit preliminary budget requests in November. The request assumes a base budget – assuming the resources that were available the previous year will again be available this year. The request are then for incremental increases (new initiatives). Reporting units fill out a Word document for requests and must identify the item requested, business purpose, whether it is a mandatory cost (legal/regulatory), and the impact. Units must prioritize their requests when submitting to the SVPSA. When the information is given to the RMM Student Affairs Advisory Committee in mid-January, the requests are organized by unit, but the Committee sees the raw data and not the prioritization. The Committee then goes through their own ranking process to prioritize requests. The SVPSA considers this information in developing his preliminary request. The SVPSA then submits preliminary budget plans to the President in February and then continues to review and update preliminary requests until an updated budget plan is submitted to the President for finalization in April. The SVPSA is then informed what general operating funds will be made available and then initiatives are funded based on the previously established prioritization.

The budget development process is different for reporting units that are considered auxiliary operations - Department of Residence, ISU Dining, and the Thielen Student Health Center. The Department of Residence and ISU Dining follow a very specific Board of Regents process and timeline and have specific requirements due to selling bonds in the debt financing market. The

Thielen Student Health Center does not receive any general funds, but submits their budget to the SVPSA in mid-spring of each year. Also, the Thielen Student Health Center is required to make a presentation to the Special Student Fee Committee as a portion of their revenue is generated from the Student Health Fee.

There are ongoing budget discussions throughout the fiscal year as the SVPSA Fiscal Officer meets as a group with all of the budget and finance personnel from the SVPSA reporting units on a monthly basis. Additionally, the SVPSA Fiscal Officers meets individually with the budget or finance person and director of each SVPSA reporting unit on a monthly basis to discuss arising budget issues.

VP for Equity and Inclusion (Katie Davidson)

Latino Family Visit Day will be this Saturday, November 7th. The day is intended to provide helpful information about college admissions, financial aid, college life and majors in a bilingual format for both Latino students and family members; hosted by the Office of Admissions and Lambda Theta Phi Fraternity, Inc.

I attended the Iowa Latin@ Initiative Conference October 20th at DMACC Ankeny. Over 300 higher education professionals attended the event and topics centered on support of Latin@ students on our campuses. I will be sure next year's event gets on the P&S calendar.

ISCORE - Save the date for the FREE March 4th conference. I will be working with Dr. Michael Davis in the DSO on the pre-conference workshops held for faculty & staff and will promote those once I have more information. Will also get information on how staff can volunteer at the conference. Also consider attending NCORE in San Francisco next May. Contact me for more information.

details, including the logo, conference session and presenter details.
