2. Approval of the Minutes

April 6, 2017 Regular Council Meeting

3. Administrative Reports

Senior Vice President & Provost (Jonathan Wickert)

The Provost gave updates on several important issues currently affecting ISU

- Mike Richards was elected to be the new President of the Iowa Board of Regents.
- It is too early to know what kind of changes or agenda he will make, but there will be a public comment period at each Board of Regent meeting, which is a good sign for the transparency of the Board.
- The mid-year budget cuts have been made permanent to the baseline of the FY18.
- There is still some uncertainty about the future of the Leopold Center. Although the state funding has been cut, there were some private gifts to the center so they do have some funding if the governor would allow them to remain open.
- Other capital projects are finishing up and going forward like the Student Innovation Center and the Bessey and biosciences building projects.
- Enrollment estimates for FY18 will be coming in soon. The Board of Regents will be considering additional tuition increases for Fall 18 based on the cuts to state funding.
- The Board is considering forming a commission to review funding of education in Iowa. This could be an important piece in guiding how education is funded in the future.
- The Provost also reminded the Council that P&S staff plays a huge part in getting all 5100 plus students across the finish line to graduations that are taking place this weekend and we should be proud of that.

Director, University Human Resources (Emma Houghton)

Emma gave a PowerPoint presentation to provide a status update about the Classification and Compensation Review.

- The primary goal of the Review is to examine current P&S jobs and pay practices in order to design a new, market-driven structure and pay philosophy that enables the attraction, retention, and reward of P&S employees at lowa State that is aligned with our mission, and is fair, equitable and compliant.
- The expected outcomes of the review include:
 - o A. Create a University-wide compensation philosophy for P&S staff
 - o B. Develop defined job classifications and job categories
 - o C. Develop a defined pay structure
 - o D. Define pay administration processes and policies
 - o E. Define pathway for P&S career development
- Emma shared the timeline for the review and the phases of the implementation process.
- We are in Phase 1 right now, which includes project planning, philosophy development, and executive interviews with University administrators to gain more information.
- In addition, UHR is developing a collection tool to gather information from every P&S employee.
- In order to guide the process, two committees are being formed:
 - o The Extended Project Team will be comprised of senior leadership.
 - The Advisory Committee is where Faculty Senate and P&S council will be involved and be able to provide feedback and input.
- UHR will be using multiple methods to share information and updates with P&S employees including:
 - o UHR website
 - Inside Iowa State
 - o Direct email communication

o Face to face presentation, focus groups and meetings with HR liaisons

Emma addressed various questions about the timeline of the review and how reclassifications will be handled. She indicated that there is no change to the reclassification policies and procedures at this time. There may be a time in the future when there will be a freeze on reclassifications.

4. Professional and Scientific Council Executive Committee Reports

President (Clayton Johnson)

It's been another very active month for Council and I am excited to report on a few great initiatives from the past month!

Board of Regents Statement

On April 20, I provided a statement to the Iowa Board of Regents on behalf of the Iowa State University Professional and Scientific employees. You may have seen news of this in the April 27 edition of Inside Iowa State. I have included the statement, in its entirety, with you via Special Report to Council FY17SP02 and, as a Special Report to Council; it has been included in the Council Docket, located on the Meetings Page of the Council website.

The purpose of this statement, from the Regents perspective, is to offer comments regarding salary issues as the Board of Regents and university administration work through the FY 2018 budgetary process, and formulate a salary policy. In the statement, I tried to focus on a variety of concerns from Professional and Scientific employees, many of which you provided in your outreach to your constituents—Thank you!

The Board of Regents has invited the Council president to present for the past several years, and we greatly appreciate the opportunity to share our voice in this process. I hope this close collaboration will continue in the future!

Vice President for University Human Resources

As I have reported in the past, I am currently serving on the search committee for the next Vice President for University Human Resources. Over the past month, on-campus interviews were held for three finalists for this position. We will have one more candidate on campus Monday, May 15. The search committee will wrap up their work shortly after the last candidate, and I anticipate an announcement will be made by the end of May. I would like to thank all Councilors who have participated in the interview process. The person selected for this position will have an impact on all P&S employees, and your input is greatly valued!

Meeting with Dr. Ben Allen

On April 17, Jessica and I met with Dr. Ben Allen, who will take office as the Interim President of Iowa State University on Tuesday, May 9. Dr. Allen reached out to me shortly after the announcement of his selection as the Interim President in late March. As part of his acclimation to campus, Dr. Allen met with several representatives of the shared governance structure, including representatives from Faculty Senate and Student Government. Dr. Allen was curious as to the issues facing P&S employees on campus, and what P&S employees are concerned about that he can affect. We had a great conversation about a variety of issues.

One thing I would like to stress is that Dr. Allen has been very adamant that he believes in transparency and communication, and has expressed a desire to hear directly from us as questions and concerns arise. I was very glad to hear this. We have had a very communicative relationship with President Leath and the entire senior leadership team in the past, and I am looking forward to continuing in this manner.

As I'm sure you are all aware, we will have our final meeting of the 2017 fiscal year on Thursday, May 25. The meeting will be held in 3300 Marston Hall. We will also have our regular committee meetings, lunch, and a group photo included as part of the agenda for this meeting. For our new councilors, we will hold an orientation session prior to the lunch. We will send a detailed schedule for the day to you soon, so please keep an eye out for that!

Secretary/Treasurer (Melissa Gruhn)
