4. Professional and Scientific Council Executive Committee Reports

President (Jessica Bell)

The Executive Committee Retreat was held last month. Committee members participated in a program using a strengths finder. The committee discussed business matters and priority planning as developed during the July General Council Meeting.

Stacy Renfro and I met with the Presidents and President Elects for regent institution staff councils. There is something we can learn from more developed organizations.

During our monthly meeting with University Human Resources we discussed the class and comp review. Also, Council will get a seat on both the Extended Project Team and the Advisory Team.

The next Executive Committee meeting is on August 24, 2017.

I met with Provost Wickert and requested a budget of \$10,250, which was approved. We had a discussion about making the work Council does more visible on social media, for example.

The Tuition Task Force is meeting at 240 Scheman on August 9, 2017. President Allen is presenting at 10:30 a.m. There will be a listening session at noon. The session is open to anyone. I met with Faculty Senate President Tim Day and Miles Lackey about the details of the plan. They are both aware of the need to scale the university.

Questions:

[Hartwig] Wasn't the charge about ongoing review? A: We are willing to help with changes - we are looking more comprehensively now to clean it up right now.

[Wollan] I would suggest bylaw revisions once a year, and not a continuous review.

[Johnson] The last time we revised the bylaws was two years ago, we thought there would be revisions each year, collect those, and vote on them at the end of the year.

Professional Development. (Tera Lawson) The August seminar series has been cancelled. Join us on September 12, 2017, from 2:00 -3:00 p.m. for the September event with University Wellness Coordinator Stephanie Downs. We are securing speakers for the remaining seminar series. Preparations for the Professional Development Conference are off and running. Cultivating Your Adventure is set to take place on February 14, 2018. Spend Valentine's Day with us.

Representation. (Sarah Morris-Benavides)

6. Unfinished Business

Councilors met with their respective representation groups about communicating to their constituencies. Discussions occurred among the representation groups.

7. New Business

Bell - Regarding the UHR Open Forums, we are asking Council to work on three open forums for the class and comp review so that UHR can answer questions from employees and engage in a dialogue. There are forums in September, October, and November. Bell moves that this task be delegated to Peer Advocacy with support from Benefits. Seconded.

[Hartwig] What help is being requested? A: Collaboration. To help communicate about the open forums and encourage individuals to ask questions, and in helping the organization.

[Wollan] The Professional Development Committee is where it should be. [Lawson] - We would be willing to volunteer the 10/10/17 Professional Development seminar series date for this purpose. [Grote] I suspect the information will be similar for the different dates, it is to make sure the information is getting out to as many employees as possible.

[Duven] UHR would be facilitating and navigating the content.

[Lawson] Moved to add Professional Development Committee to the list. Seconded.

[Hartwig] I do not see where we are adding value, other than general function of Council to discuss the issue.

[Point of order - The Council should vote on Motion to add Professional Development Committee] [Bell moved to close discussion] Council voted on Professional Development Committee being added to the list. Three abstained. The motion passed - the Professional Development Committee will be added to the list of committees to would support this initiative.

[Lawson] This is our opportunity to tailor the information to Professional and Scientific employees for UHR. We are doing our piece as service to the constituency.

[Johnson] This is critical.

[Albertson] I would support Professional and Scientific Council involvement. The President and President Elect cannot be everywhere. Creating more involvement from the committees for these purposes to help spread that voice is needed. We should not turn it down.

[Duven] This is a good opportunity to provide critical feedback to UHR.

[Thorson] This would be building a good relationship with UHR.

[Lawson] Moved to close discussion. Seconded. Voted. The motion passed and the discussion was closed.

There was a vote on the committees - Peer Advocacy, Benefits, and Professional Development to work on the UHR open forums. One abstained. The motion passed.
