1. Approval of the Agenda

Agenda for the October 3, 2019 Regular Council Meeting was approved as submitted.

2. Approval of the Minutes

Minutes of the September 5, 2019 Regular Council Meeting were approved as submitted.

3. Administrative Reports

Senior Vice President & Provost (Jonathan Wickert)

- Presentation re: enrollment and student success tomorrow;
- Sarah Nusser stepping down in August good search committee;
- Meeting recently with Board of Regents at the Iowa School for the Deaf; approved two new degrees; approved renovation for Human Sciences and financial appropriations;
- Annual chief academic officers for the state of Iowa met recently.

Finance ISD Update (Kyle Briese)

• Brief update.

<u>Question</u>: There is currently a trend in piecemeal communication within the ISD teams reaching out in different ways; are you aware of these trends? Is there a plan to unify the process? <u>Answer</u>: We are working on how to effectively spread communication; considering getting the right information to the right folks; we are concerned about customer service and how we can communicate better.

<u>Statement</u>: There is still a lot of confusion about what is supposed to be done IN the model and what should be done OUT of the model; things seem a bit muddy;

<u>Answer</u>: We are trying to identify things that might be falling through and working with each different units' needs; the goal is to be supportive to the units.

Director of Classification and Compensation, University Human Resources (Emma Houghton)

• Brief update on where we are with the Classification and Compensation process.

<u>Question</u>: How much has this project cost and are we incurring more costs? <u>Answer</u>: We have spent what we are budgeted for and staying within budget;

<u>Question</u>: With no change in pay and benefits how do you plan on meeting the goals of retention and recruitment of new employees?

<u>Answer</u>: This project does not speak to benefits; over time, managers will be involved in talking about prioritizing increases where necessary; this takes time.

<u>Question</u>: Will this affect new employees being hired – will they potentially be hired in at a higher pay rate?

<u>Answer</u>: Yes, we need to hire and attract while continuing to focus on our current employees; this will have sensitive outcomes.

Chief of Police (Michael Newton)

• Update and information regarding new legislation re: stun guns.

<u>Question</u>: Are there any age restrictions on pepper spray? <u>Answer</u>: No.

<u>Statement</u>: Thank you for clarifying the difference between owning them and having a permit to carry them; communication is crucial.

<u>Question</u>: What does carry mean? How did they get it to their dorm rooms? <u>Answer</u>: It depends on how they carry it and the intent of having them.

Question: Is pepper spray more of a deterrent?

<u>Answer</u>: There is more of a distance with pepper spray; I still encourage common sense safety training and self-defense training.

Faculty Senate (Jonathan Sturm)

- Evaluation of teaching cohort moving this forward;
- Anti-bullying is now adopted and in the faculty handbook; keep awareness on the front burner this will help the effort;
- Continuing to keep diversity and inclusion as an important focus
- Open access getting faculty research and education data available free of charge to all;
- WorkDay and ISD conversations ongoing with administration; let's show grace to each other.

4. Professional and Scientific Council Executive Committee Reports

On September 10th President Wintersteen announced the next steps brought forward from the Campus Climate Survey. The recommendations provided from this were informed by four workgroups which some of our councilors are a part of. One of those recommendations was to improve professional and leadership development offerings led by University Human Resources which is also one of our initiatives. Another was creating a Childcare Care Task Force led by Martino Harmon to identify and evaluate solutions to improve access to high-quality, affordable child care which our Lindsay Moeller will be serving on.

John Odenweller will be serving on the Vice President for Research Search Committee being formed to hire Sarah Nusser's replacement.

I continue to meet with the ISD Advisory Committee and Workday Steering Committee to address issues as they come up. The document that I sent out yesterday was to share the overall questions we received last month and the answers as they have come from HR, Finance, ISD and Workday and will continue to follow up on the questions that have yet to be answered. I also continue to follow up on how communication of these answers will take place.

Peer Advocacy (Jacob Larsen)

Policies and Procedures (John Hascall)

 The Draft International Travel Registration Policy is available for review and comments at policy.iastate.edu until November 30th. This policy is important because it provides a way to insure faculty/staff traveling internationally for ISU business get insurance coverage for medical emergencies and/or evacuation. The insurance cost is covered centrally and is very reasonably priced. Additionally travelers can receive valuable consulting before traveling to higher-risk locations.

Professional Development (Tera Lawson)

The Professional Development would like to remind everyone of our upcoming October Council Seminar Series Event, which will be on Implicit Bias and What You Can Do.

Katy Swalwell, Associate Professor in the School of Education, will join us on October 8th from 2-3 PM in room 3512 of the Memorial Union to discuss implicit bias, help us to recognize it, and to discuss how we as Iowa State University Employees can begin to address it.

If you can't make it in person, plan to join us via livestream! The link was included in this month's Council Newsletter and is available on the Professional and Scientific Council Seminar Series Webpage. If you are unable to join us on October 8th at 2 PM, the recorded session will be posted in <u>Learn@ISU</u> approximately 1 week after the live session.

We also hope that you saw the update from our Committee in this month's Council Newsletter on the work that we have done in the past year to increase the digital accessibility of our Council Seminar Series Events in Learn@ISU.

As of September 30th ALL of the FY 19 and FY 20 events to date have been uploaded to Learn@ISU as MP4 files! This means that if you had difficulty launching the Adobe Connect sessions from Learn@ISU in the past, you should no longer have an issue playing the recordings as they will now play in any video viewing software you have installed on your device!!!

I shared with Council at the end of last year, and in our committee's FY 19 final report, we worked last year on the creation of what turned out to be a several phase process to make our Council Seminar Series Event recordings more digitally accessible. The conversion to MP4 files and a place to store them was phase one.

Now that we have the MP4 files we can create a transcript through Studio on Canvas (previously known as ARC). Which is phase 2 and this process, like the creation of the MP4 files, has to be done in real time.

After we have a transcript it needs to be reviewed and edited for accuracy. Which is phase 3 and has been taking double the time of the recording itself.

Phase 4 is using that accurate transcript to create captions on our MP4 file using Adobe Premiere Pro.

After that we can complete the final phase, which is uploading the file to the Learn@ISU training folder and switching out the link to the previous MP4 file for the MP4 file with captions.

I am sharing all of this with you today to highlight our commitment to making our Council Seminar Series Events more digitally accessible and to ask for your patience as this group of 5 volunteers continues to work to make that commitment a reality.

I'd also like to recognize Chris Johnsen and to ask that everyone give him kudos and thanks for his assistance in developing this process AND in doing all of the documentation of the process we have created.
